

Microsoft NTFS for Mac by Tuxera License Agreement

1. Subject of the License

Tuxera Inc. ("Licensor") provides the Licensee the Microsoft NTFS for Mac by Tuxera application ("Software"), and any updates and upgrades to the Software, originally copyrighted and developed by the Licensor.

The software also includes open source components developed by third parties. Different licensing terms may apply for those portions.

The Licensor retains all rights to the Software not expressly granted. No title, property rights or copyright in the Software or in any modifications to the Software shall pass to the Licensee under any circumstances. The Licensee must protect the Software like any other copyrighted material ensuring that anyone with access to the Software refrains from unauthorized reproduction, use or disclosure.

2. License Grant

This Software is licensed on individual user basis. Subject to the Licensee's compliance with the terms and conditions of this License, the Licensor hereby grants to the Licensee a one-person, non-transferable, non-assignable and non-exclusive license to install and use the Software in computers and other devices owned and exclusively used by the said person. - (c) automatically without notice from Apple if You, at any time during the term of this License, commence an action for patent infringement against Apple; provided that Apple did not first commence an action for patent infringement against You in that instance.

Preamble

The licenses for most software are designed to take away your freedom to share and change it. By contrast, the GNU General Public Licenses are intended to guarantee your freedom to share and change free software--to make sure the software is free for all its users.

This license, the Library General Public License, applies to some specially designated Free Software Foundation software, and to any other libraries whose authors decide to use it. You can use it for your libraries, too.

When we speak of free software, we are referring to freedom, not price. Our General Public Licenses are designed to make sure that you have the freedom to distribute copies of free software (and charge for this service if you wish), that you receive source code or can get it if you want it, that you can change the software or use pieces of it in new free programs; and that you know you can do these things.
